Sector Classification Review for Sukuk in FTSE Fixed Income Indexes

Since the incorporation of the IdealRatings shariah screening methodology to the FTSE IdealRatings Sukuk Index in June 2020¹, FTSE Russell has performed a thorough review with IdealRatings to determine the sector classification for sukuk that are included in FTSE fixed income indexes. Effective with the September 2020 profiles, sukuk issued on behalf of central governments will be classified as Sovereign Guaranteed with Global Industry Code (GLIC) of SGTD and Corporate Bond Sector Code (COBS) of AGEN. Sukuk issued on behalf of regional governments will be classified as Regional Government Guaranteed with GLIC of RGTD and COBS of AGEN. Finally, sukuk issued on behalf of quasi-sovereign or supranational entities will be classified with a GLIC of Sovereign Government-Sponsored (SGSP) and the COBS of Agency (AGEN) and Supranational (SPRA), respectively.

As a result,14 bonds that are currently in the corporate sector will be reclassified into the Sovereign Guaranteed, Regional Government Guaranteed or Sovereign Government-Sponsored sector effective with the September 2020 profiles. These sukuk represent 19.1% of the FTSE IdealRatings Sukuk Index on a market value weighted basis, with \$15.1 billion in market value as of June 30, 2020. Details of these changes are shown in figure 1. The changes will be reflected in other FTSE indexes including the FTSE US Broad Investment-Grade Bond Index (USBIG[®]), the FTSE World Broad Investment-Grade Bond Index (WorldBIG[®]), and FTSE Emerging Markets Braod Bond Index (EMUSDBBI).

The classification of 10 bonds that are currently classified as Sovereign Government-Sponsored will also be changed to Sovereign Guaranteed or Regional Government Guaranteed, effective with the September 2020 profiles. The COBS for these bonds will remain as Agency (AGEN). These sukuk represent 25.1% of the FTSE Ideal Ratings Sukuk Index on a market value weighted basis with \$19.9 billion in market value, as of June 30, 2020. Details of these securities are shown in figure 2. The changes will be reflected in other FTSE indexes including the FTSE USBIG, FTSE WorldBIG, and FTSE EMUSDBBI.
